## Extra organics collection event happening Oct. 30 – Nov. 3

It's officially fall which means organics materials will now be collected monthly. The collection will happen on the second week each month until spring. This year, the City is introducing four new extra organics collection events to help residents dispose of extra organics waste and the next one is happening October 30 – November 3. During this week, on your regular waste collection day, you can put out extra yard/organics waste in a brown paper lawn or yard waste bag for pick up alongside your carts.

This will be the last extra organics collection event for 2023. Stay tuned for the 2024 dates.

Please note that during the rest of the year, only the amount of organics waste that will fit inside the green organics cart with the lid completely closed will be collected and bagged or other organic materials placed outside of the cart will not be collected. During these times, if you have extra organics, you can save the material for the following collection date or bring your extra organics waste to the Eco Centre (up to three cubic metres) at no charge.
