### Review of the 2025–2027 Recommended Corporate Plan November 4-6, 2024

The 2025-2027 Recommended Corporate Plan will be presented to Spruce Grove City Council during a series of Governance and Priorities Committee meetings scheduled for November 4, 5, and 6 starting at 5 p.m.

The corporate plan outlines the resources required to deliver the City's programs and services, provide funding to the community, and implement Council's vision as described within the 2022-2025 City of Spruce Grove Strategic Plan.

During these meetings, Council will review the plan, discuss Administration's recommendations, and provide direction that will inform the revised 2025-2027 Corporate Plan, which will be presented for approval at the December 2 Council meeting.

### Public Question and Answer Period

### Driveway aids to be removed from streets by October 31

Driveway aids (also known as driveway ramps or curb ramps) must be removed from City streets by October 31, per Spruce Grove's Traffic Bylaw. When the snow comes, ramps can freeze to the road surface and get caught up in snow removal equipment causing costly repairs and delays for snow removal.

Ramps can be placed on driveway curbs again starting May 1, 2025.
