The City of Spruce Grove also participates with several regional partners to provide essential services to the community. Members of Council provide City representation to these external boards, committees, and commissions with representatives chosen by Council at the annual Organizational Meeting.

REMUNERATION:	City Council members are not paid honoraria by the Board. City Council members are permitted to claim honoraria to the City.
