# Save on bills, increase comfort, and improve the value of your home

The Clean Energy Improvement Program is now accepting applications from Spruce Grove homeowners who want to make energy efficient and renewable energy upgrades to their home.

Each eligible applicant can receive up to \$50,000 in low-interest financing, with convenient repayment through their property tax bill. Spruce Grove applicants will also receive a generous rebate of 7.5% of financed costs, applied directly to reduce their total financing amount, when their project is complete.
